# GARDENING: TIME FLIES WHEN YOU'RE HAVING SUN!

HANNA'S RAIN SPELLS GOOD NEWS FOR FALL

Is time flying faster or am I just getting older? When I look back at the things I said I was going to do in the garden this summer, it seems as though I never got around to doing many of them at all! What about all the weeds that have crept into the flower beds, the brick paths, and the veggie garden, and the ivy that seems to spread everywhere even though Dan pulls some from time to time? And the Weigela that I was going to move, and the air-layering I was going to do, and the clump of Miscanthus I was going to reduce in size before it takes over the daffodil bed?

Well, it's hard to weed when the ground is dry as a bone, for one thing. And until Hanna our rains were pretty few and scanty, just enough to wet the foliage but not the ground. Even running the sprinkler for three hours on a wilting flowerbed left only the top two to three inches moist. Below that, powder! It's pretty hard to dig a new hole and plant a new shrub and keep it watered enough so it won't die when nature doesn't help with the watering. Thank goodness for

the 4.3 inches that Hanna gave us! Now we can look forward to a decent fall.

After a nice rain is a great time to think about spreading corn gluten or other germination inhibitor on those sections of the lawn that are full of summer annual weeds like crabgrass now, but will shortly be greening up with the winter annuals like chickweed and annual bluegrass. It's a good time to coreaerate the lawn as well, followed by a light application of county leaf mulch. Remember that if you use your lawnmower to mulch the fallen leaves, you won't have to rake them up, and they'll feed the lawn as they, and the fine grass clippings, decay.

Did anyone else have trouble with squirrels this year? Again I found my squash and melon plants shredded before they had a chance to grow at all, and only one cucumber vine survived unchewed. As the tomatoes grew and began to ripen, the squirrels feasted on them! I've had to pick fruits much greener than I like and try to ripen them inside. Peppers and beans remain untouched. Squirrels have also partaken of the figs, assisted by the birds, so vigilance has been required to harvest much there.

Did I mention that the birds got the raspberries again? Guess I'm going to have to figure out how to cage them next year. Maybe Nature's trying to tell me something, and I'm a slow learner! However, I still have pawpaws to enjoy, and the persimmons that are just starting. You win some, you lose

## Recent Legislation offers a tax credit for First Time Buyers

If you are a first time home buyer (classified as individuals who haven't owned a home in the last three years), and it is your primary residence, you are eligible for a federal tax credit of \$7,500 or 10 percent of the purchase price, whichever is smaller. With a tax credit, you subtract the credit amount from the total you would otherwise pay to the Internal Revenue Service. If you owe \$1,500 and you qualify for the credit, you would get a \$6,000 refund. There are two big catches, though. If you earn a modified adjusted gross income of more than \$75,000, or \$150,000 if you are married and filing your tax return jointly, the credit starts to phase out. For sinale people, it phases out completely at \$95,000 of annual income, while for married people filing jointly, it phases out at \$170,000.

But you have to **pay back** the credit over the next 15 years, in equal amounts each year when you pay your federal taxes. That makes this more like an interest-free loan than a true credit.

#### **Redefinition of Jumbo Loans**

Under the new housing bill, Fannie Mae and Freddie Mac have permanent authority to buy bigger loans in areas with high housing costs. (Temporary measures allow them to buy bigger loans, but those expire on Dec. 31.) They can buy loans up to 115 percent of the local median home price, though they cannot buy any loans larger than \$625,500. Any larger loan will generally be a jumbo loan, which will cost more in interest. Loans up to \$729,750 are available through December 31st, 2007

# UPDATE ON THE COUNTY BOARD WALK-THROUGH

Neighbors,

At the end of August we received follow-up responses to the issues addressed during the May 27 Walking Town Meeting Alcova Heights with the county board and some of the county staff.

As you may remember the issues included: pedestrian safety and traffic control at South 8th and South George Mason; traffic issues at South 7th and South Glebe; maintenance of the north side of Alcova Park; the increasing traffic and commuter parking at South 6th and South Quincy caused by construction at the Foreign Affairs Training Center; concerns associated with the Army National Guard expansion; the disposition of alleys, including maintenance and storm-water drainage; the request to block the alley between South 6th and South 7th Street; and storm water management on South Randolph.

None of these issues has a quick fix, although there have already been improvements in the care of the trees in the park as well as graffiti and kudzu removal. And the "slimy"

sidewalk on South 8th has been fixed.

The intersection at Glebe and South 7th is due to be upgraded in 2009. There has not been a final decision on the request to block the alley between South 6th and South 7th. The county is gathering usage and speed data. And the longstanding storm water drainage problem on South Randolph could be addressed by the county's newly funded storm water program.

The Foreign Affairs Center and Army National Guard issues will be more challenging as they involve the federal continued on page 6

government. On 25 August 20-plus neighbors met with staff from the State Department, the Training Center, and the Arlington County BRAC liaison. Stay tuned for a full report on that meeting. The issues of the construction workers parking on South 6th and South Quincy and the noise from the construction were heated topics. More concerns like these can be expected as the Army National Guard moves forward with their expansion in 2009 to accommodate 1,200 relocating workers. AHCA has placed our concerns in writing and in person. The real work will be to actively be a presence with the BRAC personnel as these projects move forward to realization.

As we can all see, the squeaky wheel will have the best chance of getting the oil. All issues need attention and continued monitoring. We need to let the county staff know we take our community seriously and want to work with them to resolve our concerns. That's where you come in. Consider being a part of Alcova's effort to get the work done. We have a lot of talented people in our community. I envision developing small ad hoc groups who will take on an issue and work with the county staff solve it. Come to the September 25th AHCA meeting to see how you can be a part of the solutions. #### **Arlington County Board Approves Accessory Dwellings**

On July 19, 2008, the Arlington County Board approved changes in the zoning ordinance that will allow accessory dwellings in single-family homes and non-relatives to live in family/caregiver suites in single-family homes. The board also enacted strict requirements for accessory dwellings, including a cap that will restrict the number of new accessory dwellings to no more than 28 a year. In addition, the board directed staff to prepare, before the end of the year, a proposed Zoning Ordinance change that would provide for civil penalties for zoning violations, including overcrowding.

The changes came after months of public discussion and review by civic associations and county advisory boards.
