Anne (Elly) Merica is the current president of the Alcova Heights Civic Association. She took a little time out to talk about her time living here, what her role is, and what she hopes the civic association can accomplish.

How long have you been here?

Does being an architect influence your approach to the role?

We need activities that bring the neighborhood together rather than split it into subsets. We need to update the Neighborhood Conservation Plan to include the homes north of the fire station and to address the issues brought up in the Form Based Code for Columbia Pike. We also need to get fresh, new perspectives and energy to continue our traditional events such as the Halloween Parade and National Night Out, and to develop new traditions such as the Holiday Caroling and Bonfire.

RECIPE CORNER

Lowfat Raspberry "Trifle" | Serves 6

It is best to prepare trifle at least 6 hours before serving so that the ladyfingers have time to soften. I like to make it in the morning for an after-dinner dessert.

Ingredients:

3 cups plain fat-free yogurt

1 cup part-skim ricotta cheese

12 oz unsweetened frozen raspberries 20 ladyfingers cookies (packaged or home-made)

Mix yogurt and ricotta cheese together in a medium bowl, set aside. Place ten ladyfingers in the bottom of a 9x9 inch glass pan. Place about half of the frozen raspberries on top of the ladyfingers. The berries should be plentiful, but should not completely cover the ladyfingers. Next, spoon half of the yogurt mixture over the berries, covering berries and ladyfingers completely (about 1/4 - 1/2 inch deep). Place a second layer of ladyfingers over the yogurt. Cover the ladyfingers with most of the remaining raspberries, but keep a handful to use as garnish. Spoon the rest of the yogurt mixture over the berries. Sprinkle the trifle with the reserved frozen berries. Cover the pan and refrigerate the trifle for several hours, until ready to serve. The trifle is best if eaten within 24 hours.








Alcova Heights sales numbers in 2006 totaled <u>17 units sold</u> compared to 22 units in 2005. <u>The average sold price was \$614,076</u> compared to the average 2005 sale price of \$673,258. Most of the properties had price reductions from their original list price, and many were re-listed in the MLS system. <u>The final list price</u>, not the original list price, is what is used in these calculations. Average days on the market in 2006 were 25 in 2006 (down from the 60 day average in 22204 because of a few private sales)

Recently in Northern Virginia we have seen an increase in buying activity with the declining unsold inventories. From the 2nd quarter of 2006 through the 4th quarter of 2006 there is evidence of 10% to 20% asking-price reductions seen. Price cuts in the housing prices have stimulated buyers who had been sitting on the sidelines wondering when the market might bottom out to move back in and start shopping. The Washington DC area economy remains solid, with strong employment and significant in-migration.

As inventory continues to decline, the selection of homes will once again become limited. For prospective buyers, there may never be a better time to buy a home than right now. Research indicates that home prices will not go any lower. While certain local markets across the country may see limited price declines, the national and local DC area picture remains bright.

Many industry experts are using the term "normalization", meaning that the housing market is returning to its long-term trend line. The correction process began during the summer of 2005. Current conditions are looking favorable for a balanced real estate market as long as interest rates remain attractive and affordability is there for buyers.
