National Capital Land will discuss plans for the development of 20 townhomes along Columbia Pike between S. Randolph and S. Quincy. (See story below.)

A citizen volunteer, Cynthia Kellams, will present information on Community Emergency Response Training, a program wherein local residents receive training to supplement the emergency services of the local, state and federal first responders. Alcova Heights may elect to participate in this training.

There will be a brief report on the progress of traffic calming efforts for 8th Street. The AHCA is grateful to Project Leader Tom Schelstrate, who is leading current petition efforts and to former Traffic Chair Ruth Yamamoto and the Traffic Committee for their efforts in this endeavor.

A representative of the Arlington County Department of Public Works will provide a brief presentation on ART and Metro bus service for Columbia Pike.

TOWNHOUSE PROJECT NEARS APPROVAL

Plans for the proposed townhouse project on Columbia Pike between Quincy and Randolph Streets continue to move forward. The 22 unit project has been planned using the new Columbia Pike Form-Based Code as a guide. The units will front directly on Columbia Pike and Randolph Street at street level. Each unit will have a two-car garage which will be accessed from the rear. A large wooded area will be preserved at the back of the property to serve as a buffer for the adjacent homeowners. The units are expected to sell in the \$400,000+ range.

A working group made up of Alcova Heights residents, as well as representatives from Douglas Park and Barcroft, have been meeting with the developer, National Capital Land Company, since November. The developer has been surprisingly responsive to our concerns and suggestions. The project as now proposed, is a vast improvement over the first proposal. There are still some issues to be resolved, but we expect that these issues will be addressed to our satisfaction.

The construction period will undoubtedly be unpleasant and a bit of a shock, as many of the trees on the site will be removed and much of the hillside will be cut away. However, the community working group has worked hard to ensure that the final product will reflect positively on Alcova Heights and be an asset to the Columbia Pike community. We believe that we have succeeded.

To learn more about the project, please attend the May 13 meeting of the Alcova Heights Citizens Association. The developer will be on hand to present the project, and we will take a vote on whether or not to support the project. The project will go before the County Board on Saturday, May 17. If approved, construction will probably begin this fall. If you have any questions, please contact Lander Allin at 703-553-9286.

LEFT TURN CONSTRUCTION UNDER WAY

The long-awaited construction of the left turn lanes at Columbia Pike and Glebe Road is finally underway. The project has been delayed for years, because the

necessary right-of-way and easements could not be acquired. That process was completed in March. The relocation of the utility poles and lines is now underway and should be wrapped up by the end of April. County staff is now preparing to advertise the project for construction bids. Construction start is planned for August with completion expected by November.

The new turn lanes will allow left turns from all four directions. This will reduce the amount of traffic cutting through Alcova Heights. They should also help relieve some of the congestion at the intersection.

After the turn lane construction is complete, construction of the streetscape improvements from Highland Street to Oakland Street can begin. Those improvements will include undergrounding the utility lines, installation of Carlyle-style streetlights, construction of brick sidewalks and the planting of street trees. The schedule for that project has not been announced.
